

Data protection

We would like to inform you about the data protection aspects when using the page "apura-yoga.com" as follows:

1. Information on the website called "Apura Yoga":

- The person responsible for Apura Yoga is (Owner: Donovan Longaker, Hölderlinstr 5, 73087 Bad Boll, Phone: +49 17699997790, E-Mail: info@apura-yoga.com) (and is referred to hereinafter as "we" or "us").

- Your IP address will be processed. The processing is for the purpose of being able to present to you the contents of the website. The legal basis for processing the data is subject to the preservation of legitimate interests in accordance with. Art. 6 lit. f DSGVO and the processing for the implementation of pre-contractual measures acc. Art. 6 lit. b DSGVO, as far as you request them.

- The said legitimate interests acc. Art. 6 lit. f DSGVO consists of the fact that, technically, third parties must be involved in web page transmissions (internet service providers). Without the involvement of third parties, the presentation of the content in your Internet browser is not possible. The involvement of the third party is limited to those directly involved in the communication process.

Apura Yoga will erase the data immediately upon the completion of the contact with you, unless otherwise stated below. If you request deletion beforehand, the data will be deleted immediately, unless there is another legal basis for the processing.

Apura Yoga integrates a hosting service provider for the website via order processing, namely Hostgator, www.hostgator.com. This hosting service provider is strictly bound by instructions from Apura Yoga.

- Cookies: Cookies are used on our website. A cookie is a small file that can be stored on your computer when you visit a website. Basically, cookies are used to provide users with additional features on a website. For example, they may be used to help you navigate a website, to allow you to continue to use a website where you left it, and / or to save your preferences and preferences when you return to the website. Cookies can not access, read or modify any other data on your computer. Most of the cookies on this website are called session cookies. They will be automatically deleted when you leave our website. Persistent cookies, however, remain on your computer until you manually delete them in your browser. We use such persistent cookies to recognize you when you next visit our website. -Google analytics: We use Google Analytics, a web analytics service provided by Google search engine (Google Inc., 1600 Ampitheatre Parkway, Mountain View, CA 94043, USA). Google Analytics uses cookies on your computer which are stored and allow an analysis of your use of the website. We process your data on the basis of legitimate interest (see Art 6 para 1 lit. DSGVO) in order to provide an easy-to-use website

-Create access statistics -The information generated by the cookie about your use of this website (including your IP address and the URLs of the called websites) are transmitted to Google servers in the US and stored there. We do not store any of your data relating to Google Analytics that are collected. This website uses the terms of Google Analytics which offers the possibility of IP anonymization. Your IP address will therefore be Google's shortened / anonymized format as soon as Google receives your IP address. In our order Google will use this information to evaluate your use of the website, to compile reports on the website activities and to further the website and internet usage services provided. The IP address transmitted by Google Analytics as part of Google Analytics will not be merged with other data by Google. - There is a right to information, rectification or cancellation or restriction or right to object to the processing. The right to objection of processing your personal information is in accordance with. Art. 6 lit. f DSGVO and we are willing to comply and abide by the GDPR rules and regulations.

- There is a right of an appeal to the supervisory authority.

- The provision of personal data by you is neither legal nor contractually required or required for a contract. You are not obliged to provide the data. Possible consequences if you do not have the data is that you use the website of Apura Yoga in whole or in part but will not be able to retrieve or be unable to perceive the content accordingly.

- There is no automated decision making and no profiling.

You have that right to revoke any of your consent at any time. By the revocation of the consent, the legality of the processing is effected on the basis of the consent until the revocation. You can request a revocation, e.g. explain by e-mail to Apura Yoga. The data concerned: The data you entered in the contact form. In addition, technically and conditionally: your IP address, the date and time, and your e-mail address and content of the consent to which you are requested directly from the contact form:
